EDNA TOWNSHIP MEETING April 16, 2019 www.ednatownship.org

The meeting was called to Order at 8 p.m. and began with the Pledge of Allegiance.

Dennis Sazama, Carol Nelson, Gary Schattschneider, Echo Dockter and Karen Marthaler were present.

Sazama made a motion to accept the agenda with changes, Schattschneider 2nd the motion and it passed unanimously.

Sazama made a motion to accept the clerk's report. Schattschneider 2nd the motion and it passed unanimously.

The Treasurer's Report shows receipts of \$5379.47, disbursements of \$45,558,58 and working capital of \$ 279,358.53.

Sazama made a motion to accept the Treasurer's report as presented, Nelson 2nd the motion and it passed unanimously.

There was a gopher bounty to be paid. 37 pairs of gopher feet were presented.

The claims for payment were reviewed. The gopher bounty claim was added, also the claim from Compass Consultants and a claim from the Treasurer to move the last of the interest from United Community Bank to Bremer. Sazama made a motion to pay all of the claims listed and the additions. Nelson 2nd the motion and it passed unanimously.

The resolution to adopt, update and record the Edna Township roads was read by Nelson (see attached resolution).

Schattschneider motion to adopt this resolution, Sazama 2nd the motion and the resolution passed unanimously.

The road report opened with a discussion of the bump on East Little McDonald, near the pump house that caused considerable damage to the snowplow. Justin Rodeman from Mark's Sand & Gravel was notified and will be contacting Torey. There is no need to contact to MAT insurance.

Nelson made a motion to accept the quote from Lot Pros for \$48,800 for these roads. Sazama 2nd the motion and it passed unanimously. This is for crack sealing only. The quote from Tom Grahm was a per hour amount and the supervisors were not comfortable with no limit on the total.

Signs – Torey reported that the signs are 80% are put together. The request from the annual meeting, to spread the No Parking signs on East Little McDonald Rd out was discussed. The conclusion was to pull 4 signs, move 3 to the south and 1 to the north. It is the belief of the Board that no one will park in between the signs. The rest of the chevrons, the STOP sign by Doug Ackling's shop, the minimum maintenance sign by 380th (Gary Benson) and the BUMP sign near East Little McDonald will be done, probably by the May meeting. the No Parking signs should go to the south, pull 4 out and put 1 on the North and 3 on the South. The rest should be in by the May meeting. There are still roads that need to have signs posted.

Jeff Stabnow will write up the specs for the sealcoating of North and East Little McDonald, the new asphalt. This should be 1.5 miles. This should be determined at the May meeting.

Mailbox policy is attached for review. After discussion, and the viewing during the Spring road inspection it was determined that 10 mailbox supports will be replaced. Edna will supply the supports and Torey will install them. Dennis has the supports that have already been paid for. Dennis is going to call the 10 property owners.

Snow removal policy – 2013. This was tabled for another meeting.

Utility/right-of-way policy/permit. Carol presented the first draft this meeting. Discussion will continue. Correspondence:

Scott Bucholtz for Rick Swenson, moving approach, Dennis visited with him and determined no approach permit was needed. Dennis will give him a copy of the policy.

Jim Fick - email for OT County variance, Carol responded.

Unfinished business:

The Board did not vote to reorganize at the March meeting because Schattschneider was unable to attend. Sazama made a motion to keep the Board as it was standing. Sazama will be the chairperson and the road authority. Nelson will be the Vice Chair, Schattschneider will be the Weed control officer. The motion was 2nd by Schattschneider and passed.

There was a quick discussion of chloride for dust control. North Central has done it in the past with the best results. Torey will talk to Curt at North Central about the 3 or 4 spots that need chloride and will coordinate the grading and spraying.
