## Regular Board Meeting January 14, 2025

The meeting was called to order at 7pm and began with the Pledge of Allegiance.

Ben Bucholz, Keith Brokke, Kenny Moenkedick and Echo Dockter were present. Karen Marthaler joined the meeting via Facetime.

The agenda was reviewed. Bucholz motioned to accept the agenda with a few additions. Moenkedick 2<sup>nd</sup> the motion and it passed unanimously.

The minutes of the December meeting were reviewed. Brokke motioned to accept the minutes with a correction. Bucholz  $2^{nd}$  the motion and it passed unanimously.

The Treasurer's report showed receipts of \$4,374.81, disbursements of \$33,042.97 and working capital of \$266,649.28.

Brokke motioned to accept the report as presented. Bucholz 2<sup>nd</sup> the motion and it passed unanimously.

There were no bounties to be paid.

The claims for payment were reviewed. Bucholz motioned to approve the claims. Brokke 2<sup>nd</sup> the motion and it passed unanimously. Bucholz motioned to approve the transfer of \$23,761.89 from the money market account to the checking account. Brokke 2<sup>nd</sup> the motion and it passed unanimously.

The updated policy was discussed. Bucholz motioned to approve the policy and have it posted to the website. Brokke 2<sup>nd</sup> the motion and it passed unanimously.

363<sup>rd</sup> Ave was discussed. It was not listed in the recorded document of all the township roads. The township has previously applied minimal gravel to this road (2022 and 2024). At this point is appears it is a minimum maintenance road only for the length maintained in 2022 and 2024, which is 'just over the hill'. Moenkedick will look into this.

Bucholz discussed the agenda for the upcoming January meeting of EMS.

Moenkedick stated that the compaction reports for the Stony Hills First Addition are still not available so this issue is on hold.

Bucholz reported that Hobart Township was not ready to make a decision on the road work for 460<sup>th</sup> for 2026. They have decided not to do any major work in 2025. Note that no repair work was done in 2024.

Filing for township positions ended at 5 pm today. Bucholz filed for the supervisor position, Marthaler filed for the Treasurer position. There were no other filings.

The Annual Audit was conducted at this time. The Clerk's and Treasurer's registers were presented. All the bank statements for the year were available.
