Regular Board Meeting March 22, 2022

The meeting was called to order at 7 pm and began with the Pledge of Allegiance.

Dennis Sazama, Gary Schattschneider, Ben Bucholz, Echo Dockter and Karen Marthaler were present. Other attendees are listed on the sign in sheet, attached.

The agenda was reviewed. Bucholz moved to approve the agenda as presented. Sazama seconded and the motion passed unanimously. Bucholz and Dockter received their Certificates of Election and have filed their Oath of Office forms. Sazama made a motion to keep the Board positions the same. Sazama will be the Chair and Emergency Road Authority, Schattschneider the Vice Chair and Bucholz will be the Weed Inspector. Bucholz 2nd the motion and it passed unanimously.

Sazama moved to accept the clerk's report of the February meeting as presented. Schattschneider 2nd and the motion passed unanimously.

The Treasurer's Report showed receipts of \$44,278.90, disbursements of \$31,634.69 and working capital of \$828,429.33. Sazama moved to approve the report as presented. Bucholz 2nd and the motion passed unanimously.

There was a bounty to be paid for 378 pair of gopher feet. This was added to the list of claims for payment.

The claims for payment were reviewed. Sazama move to pay the claims, Bucholz 2nd and the motion passed unanimously. Sazama made a motion to move \$46,906.86 from the money market account to the checking account. Schattschneider 2nd. Sazama, Schattschneider and Bucholz voted to pass the motion.

CJ Holl and Bridget Holl, Edna residents on Big McDonald Lane, attended the meeting to explain their plans to build/remodel and their probable need for a variance. The Board agreed the changes they are proposing would be acceptable to the township. The property is located at 34820 Big McDonald Lane. A letter of acceptance will be provided if needed.

The email from the county highway department, regarding the request for reimbursement for the costs of maintaining Fort Thunder road during the County Road 34 reconstruction, was discussed. Schattschneider volunteered to respond.

The Spring Road Tour is set for Sunday, April 10, starting at noon at the Dent Community Center. This meeting will be recessed to reconvene at that time.

Dockter received a Summons and Complaint regarding East Paul Lake from the Karkela law office. Schattschneider has a phone conference set up with Attorney Felix on Wednesday the 23rd to determine what, if any, response the township will make.

Because of redistricting the township has to pass a resolution to reestablish the polling place. The Resolution is attached. Sazama made a motion to pass the resolution, Bucholz 2^{nd} and it passed unanimously.

Bucholz volunteered to work on the Southview Lane issue.

Lake Region has been trimming trees on North Little McDonald, Wolf Lake and South Little McDonald. Arvig will be installing fiber cable this summer. Map attached.

The list of unfinished business was reviewed. Other than the items already discussed there are no changes.

The moderator for the annual meeting is usually paid a fee for performing this service. The fee has been \$50 for decades. Sazama moved to raise the moderator fee to \$100 effective for the 2023 annual meeting. Bucholz seconded and the motion passed unanimously.

The meeting was recessed at 8:40 pm. It will reconvene at noon on April 10, 2022 at the Dent Community Center.

The meeting was reconvened at noon on April 10, 2022. Sazama, Schattschneider and Bucholz were the only ones present. Schattschneider recorded road conditions using the road spreadsheet.

The meeting was adjourned at 4:30 pm.
