Edna Township

Regular Board Meeting July 19, 2022

Dent Community Center, 201 Birch St, Dent MN 56528

The meeting was called to order at 7 pm and began with the Pledge of Allegiance.

Dennis Sazama, Gary Schattschneider, Ben Bucholz, Karen Marthaler and Echo Dockter were present

Bucholz motioned to accept the agenda as presented. Sazama 2nd the motion and it passed unanimously.

The minutes from the June regular meeting and the special meeting on July 5th were reviewed. Bucholz motioned to accept the minutes from both meetings. Sazama 2nd the motion and it passed unanimously.

The Treasurer's report showed receipts of \$37.88, disbursements of \$255,108.32 and working capital of \$666,381.77.

Bucholz motioned to accept the report as presented. Schattschneider 2nd the motion and it passed unanimously.

The claims for payment were reviewed. Sazama motioned to pay the claims as presented. Bucholz 2nd the motion and it passed unanimously. Sazama motioned to approve the transfer of \$62,220.066 from the money market account to the checking account. Each of the supervisors voted in favor of the motion.

Larry Mollins was present to discuss the dust on W Little McDonald Dr (Kerbs Lake). The new dust control policy was reviewed. This road is on the list to be worked on in 2023.

Karen Gibson presented the check and completed form for dust control on Devils Lake Rd. Bucholz will contact North Central to schedule the application of the dust control and will contact the Devils Lake Road representative.

The phone calls for the month were reviewed.

There were several calls about the dust problem on Devils Lake Road. This prompted the special meeting and the Dust Control Policy.

The mailbox at 42748 Engstrom Beach was not on a swing away post. Sazama returned the call and explained the policy.

The request to replace a damaged sprinkler was denied. The sprinkler was in the road right of way.

The missing street sign at the corner of 460th and N Little McDonald was reported and a call was made to the county highway department.

Mike Satter called about 355th. Schattschneider agreed it needed grading, this was done on the 15th. Schattschneider also explained the dust control policy.

The chevron sign by 37179 S Little Mc and the curve sign by 37105 S Little Mc are down. Resetting the chevron sign will be added to the subcontractor list. The curve sign just needs to be removed. It was also noted that there is a Road Closed sign in the ditch. The resident has moved it so he could mow. Marthaler will get permission to remove the sign.

Schattschneider volunteered to collect the signs and move them to the storage shed.

The pothole on the corner of Jackim and 395th has been added to the subcontractor list.

The branches on this same corner need to be trimmed so the STOP sign will be visible. This will be added to the subcontractor list.

The shoulder washout on N Little Mc, between W Little Mc and the boat access, on the swamp side of the road will also be added to the subcontractor list.

The hole in the road on 385th has been filled once with rocks. It seems to be getting worse. It looks like an old muskrat hole. Sonnenberg suggested patching it instead of digging it up. Newling Asphalt was suggested to patch this and the area over the culvert replacement on E Big Mc and the pothole on Jackim Dr. Schattschneider motioned to approve Newling Asphalt handle these areas. Bucholz 2nd the motion and it passed unanimously.

Dockter has ordered the double arrow signs requested in June. 3 signs and 1 set of posts.

There was a lengthy discussion irrigators spraying the road on 395th and 405th St and 423rd. The irrigators require a domestic well certificate from the state. The information Sazama discussed at the June meeting and the discussion at the July meeting indicate that a well certificate can be revoked if the operator does not comply with the request to stop

watering the road. The first step is to talk to the operator. This should be followed by a polite letter. Sazama has the first draft of the letter. Dockter will move it to township letterhead and send it out to all supervisors. Sazama will be in charge of this project.

The variance request for 42674 Engstrom Beach Road was not acceptable to the township. Sazama attended the variance hearing to state the township objections to this request. The main objection to the request was the stated intention to use the road right of way as the designated parking area when they removed the driveway. The variance committee agreed that the road right of way can't be used as a designated parking area.

The pond side of 432nd is washing out. 432nd is part of CH131 that Edna took over from the county. Sazama and Stabnow reviewed the area that is washing out. It was agreed that dirt must be put it to fill the gullies. This needs to be "bucket packed" and hydro spray applied. Bucholz questioned why this was not done originally. Sazama and Stabnow had reviewed this spot last summer and decided not to do any more work at that time. Sazama motioned to repair the bad spots on 432nd, including both sides of the road. The repair is to include the dirt, packing and spraying. Schattschneider 2nd the motion and it passed unanimously.

There are washouts on Mallard Loop that have become a problem since the bike path was installed. Sazama met with Chuck, from the county highway department, on July 15th at the site. There used to be a ditch between Mallard Loop and County Highway 34. The reconstruction of County Highway 34 and the addition of the bike path removed the ditch. There were a couple different suggestions to fix this problem. The Board proposed that the county needs to come back and fix the problems created by the bike path. The township will not do anything with the road until the county fixes the ditch problem.

Sazama reviewed the access approach permit request for W Little Mc. He agreed that the culvert could be more than 20 ft. Sazama contacted Lake Region regarding the cuts in the asphalt roads in the township. They said they did it and these spots will be fixed. We are to contact them if anything is not fixed correctly.

The 3 year rotation for the gravel road maintenance will be listed on the website.

The access approach on the north side of E Big Mc Dr has been completed and approved by Sazama. The check will be returned.

The plat for Overland Acres was reviewed and the Board had no objections.

370th is still ROUGH. The company did another shot of oil to fix the problem. This did not work. Stabnow is working with Astech to fix this road. It was noted that no payment has been made.

The township will have to continue to mow the ditch by Dave Taylor's property at least once a year as long as there is spotted knapweed in that pasture. The property owner is not required to spray, only to mow before the weed goes to seed. The hay from this pasture can be transported, as long as there are no seeds. Bucholz contacted the county and researched this thoroughly.

The grass is not growing on the areas of Devils Lake Rd that Gorman Township planted. Bucholz will contact Gorman to have it replanted. The Board suggested hydro spray.

The subcontractor list was reviewed. Several items were added during the meeting. An updated list will be emailed and added to the minutes.

Note the MAT District 9 meeting on Monday August 15,2022 in Alexandria.

Election Judge training finished on Monday. Waiting for confirmation that all possible judges did do the training. The list of judges includes: Echo Dockter, Carol Myhre, Pam Bruhn, Patti Paul, Jane Kihl-Kippley, Bridgette Holl, Sue Flatau, Elizabeth Dunlap and Darla Wendlund. The schedule for the Primary election will be set up this week. The Primary election is August 9.
